The Redfield School Foundation was established in 2003 to provide a permanent source of financial support to Redfield Public Schools. An independent, tax-exempt nonprofit organization, it supports the school in two fundamental ways: making grants to school staff for projects that meet priorities established by the board of directors and raising funds to meet capital needs.

It is the first year without any construction since the spring of 2016. Last year, on February 17, the auditorium opened. During the auditorium dedication ceremony, the school board opened the time capsule, the choir performed, and the evening culminated with the high school band performing the school song. Unfortunately, due to the COVID-19 pandemic, we were not able to make use of the auditorium for events.



The school board approved the expansion of the weight room in the Greeno building. The two bathrooms and concession stand were demolished to make the weight room expansion possible. This final project turned out great and will draw your eye to the weight room when you walk into the Greeno building from our activities entrances. The completion of our school could not have been achieved without the support of our community and alumni.

Scholarships Support Graduates

The Redfield School Foundation manages the Redfield High School Alumni Association scholarship fund, which supports graduating seniors. In mid-2020, the fund's balance was just over \$255,000. Today, it includes 15 scholarships, and in mid-2020, 13 graduating seniors received 17 scholarship awards totaling \$10,800. Since 1976, more than \$216,000 has been awarded.

Financial Overview 2019-2020

The Foundation began the 2019-2020 fiscal year with a balance of \$270,541 and ended at \$273,519, after a rocky COVID spring. During the year, income totaled \$22,946 through donations, memorial gifts, and investment return. Over \$10,200 was distributed to the school for grants. Other expenses accounted for about \$11,000. The Foundation is implementing a plan to invest its assets with a target of about 50% in equities and the remainder in cash and fixed investments.

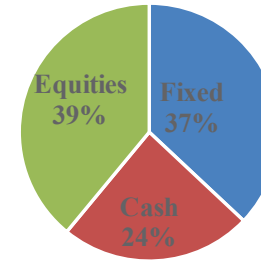
Due to the pandemic-impacted school year, no grants were made.
